pharmacy, and one check out, and the customer service desk. They appreciated our help and have sent a donation to our Rochester chapter! Loops are now also installed at the Pittsford Plaza Wegmans. Now here comes the request--they need/want our feedback!

We're asking each one of you to use the loop.. If it doesn't work for you, say so. Above all, if the person behind the counter says that they don't know how to use it – speak up, ask them to find someone who can show them. If they aren't sure, I show them my remote control, show them how I change it to telecoil (it shows up on tiny screen on the remote) and explain it. Wegmans has gone to great lengths to install these loops, and we need to get back to them not only with constructive comments but also with praise! Very few people even inquire as to what the blue "ear with line through it" sign means. We have a ways to go!


HLAA CONVENTION, ST. LOUIS, MO., JUNE 2015

Seven members from our Rochester chapter attended. As always, the convention was inspiring and motivational. Above all, the camaraderie amongst the 1000+ attendees is wonderful – it's so easy to talk to anyone because we all understand our needs. Sen. Tom Harkin, IA, who is one of us, gave one of the opening convocation talks including mention of <u>HR 1653, a bill requesting Medicare</u> <u>coverage for hearing aids.</u>

Workshops, demos, and the exhibition hall were full of technology; the conventioneers were told that's what you wanted to hear about.

The CTI – <u>Consumer Technology Initiative</u> – is the new HLAA concept in hearing enhancement technology. Rather than focusing on HAs/CIs as the sole solution to hearing difficulties, **especially hearing in noise**, picture the new concept as a group of overlapping rings with a central integration point surrounded by concentric rings of hearing accessibility.



The central ring is you as an individual and whatever technology integrates your hearing needs best with what's available; for example, smart phones + internet. The outer rings include Apps, HAs and CIs, best practices, ALDs and consumer hearing devices.

Due to complexities in the hearing health care delivery system, finding the right technology for you may be daunting. This new concept partners with consumers and providers to demonstrate how new and emerging assistive technologies can help. <u>HLAA is</u> <u>developing an online product directory where we</u> <u>will be able to locate products and services to</u> <u>enhance hearing in various communication</u> <u>situations.</u> This directory will allow the consumer to review and rate products, link them to their website, and engage in online discussion about them. This is a brand new idea – stay tuned – you will be hearing much more, especially on hearing in noise, one of our most prevalent issues.

Cochlear Americas is excited to announce that the FDA approved the Cochlear[™] Nucleus[®] 6 Sound Processor Upgrade for the Nucleus[®] 22 Implant.

FDA approval is the first of many steps to launch a new upgrade. Cochlear is currently assembling inventory and working diligently with software engineers to release a software update needed for audiologists to program the Nucleus 6 Sound Processor for the Nucleus 22 Implant with a full-market release about October 1st.

- --I am not able to hear well, and I may not be able to communicate effectively in all situations.
- --I use speech reading to communicate. Please do not shine a light in my eyes or cover your mouth with your hand.
- --Please face me and speak clearly.

- --Please speak slowly and don't shout--shouting distorts your voice.
- --Please write notes if necessary.
- --Please have your dispatcher send a sign language interpreter.



Our speaker is **Dr. Richard Salvi**, Distinguished Professor at University of Buffalo; Chair, Dept. of Communicative Disorders and Sciences. He is one of six Distinguished Prof's in the entire SUNY system--distinguished professor, distinguished service professor and distinguished teaching professor. Considered a pioneer in research on hearing and deafness, his main area of research is the auditory physiology associated with acquired hearing loss. He has numerous publications dealing with the anatomical, physiological and perceptual deficits associated with noise-induced hearing loss, ototoxic, and age-related hearing loss. Dr. Salvi was one of the first to use brain imaging techniques in his studies of tinnitus, and he has also done brain imaging to identify the functional changes occurring in the central auditory pathways following sensorineural hearing loss. Studies on hair cell degeneration/ regeneration, and stem cell therapy are included in his resume.

His many awards include a \$2 million grant from the Navy for studies on tinnitus and related topics.

Dr. Salvi will speak about how the auditory system works and some of the consequences of auditory pathway breakdown, including the potentially debilitating symptoms of tinnitus and hyperacusis (sensitivity to loud noises).

Note: the Academy is 0.9 mile farther down East Ave. from St. Paul's, going away from downtown, on same side of East Ave. as the church.


