A couple of months ago I touched on a few services the **HLAA Rochester Chapter** has to offer and how we can help facilitate better communication between a person with hearing loss and their spouse or partner. This has always been a hot topic among our chapter members.

This month I'd like to add more to that topic especially since our chapter will be offering a special Zoom only session with a licensed psychologist who will be speaking on this very topic. April 18<sup>th</sup>, 2024 is the date and the time will be from 7 pm to 8 pm. <u>Meghan L.</u> <u>Fox PsyD</u>, a local psychologist, will be our guest speaker.

If you are interested in attending, (don't forget to encourage your spouse or significant other to attend as well) please visit our website to register for the "HOPE in the Evening" session. Once registered you will receive the link via email within 24 hours of the event. If you have attended or received the zoom link for HOPE sessions in the past you do not need to register again.

Although our chapter has covered this topic in the past, it's a topic often overlooked that has significant impact on our on our personal relationship with someone we care about. Recent studies have shown that untreated hearing loss can have adverse effects on various aspects of an individual's life, including their relationships with their spouse or partners

When one partner experiences hearing loss, communication barriers may arise, leading to misunderstandings, frustration, and feelings of isolation. Simple tasks such as conversing over dinner or watching television together can become challenging and may eventually strain the relationship. The inability to effectively communicate and connect with one another can lead to feelings of disconnect and resentment, potentially causing emotional distance between partners.

It is crucial to address hearing loss proactively to preserve the quality of relationships. Seeking professional help and exploring treatment options such as hearing aids (including Cochlear Implants (CIs) & Assistive Listening Devices (ALDs)) can significantly improve communication and enhance the overall quality of life for both partners. By taking proactive steps to address hearing loss, individuals can mitigate the negative impact on their relationships and strengthen their bond with their spouses or partners.

In conclusion, I urge you to prioritize your hearing health and seek assistance if you or your partner are experiencing hearing difficulties. Open and honest communication is essential in any relationship, and addressing hearing loss can help foster better understanding and connection between partners.

So don't be that person statistically that waits up to 7 to 10 years before doing something about your hearing loss. Believe it or not this hearing loss isn't affecting just you... another example of why "*Better Hearing* = *Better Living*"



## **National Report**

Many of us remember fondly the days when the Roch-

ester chapter joined with national HLAA to hold a Walk4hearing event here in Rochester. Rochester chapter was one of six chapters to hold an inaugural W4H in 2006. The annual early May date marked for many of us the first true day of spring. Robust crowds made up of people of all ages en-



crowds made up of people of all ages enjoyed the good food, live music, entertainment by clowns, and the fellowship and goodwill that marked our time together. In its day, the local W4H event was one of the ways the Rochester chapter attracted new members into our midst.

Although the Walk4Hearing no longer takes place locally, the W4H program continues in cities across the country and remains an opportunity for Rochester chapter members to raise funds for national HLAA and for Rochester chapter, even if attending the event in person is not a possibility. Some 17 events are scheduled as of this writing and an additional four await the determination of the event date. For more information, see the Programs and Events tab at hearingloss.org.

I am often asked about how the funds raised by Walk4Hearing participants is distributed so I will cover that question here. 80 % of each dollar raised by participants is split evenly between national HLAA and by the local chapter or other "alliance" organization as designated by the individual participant when s/ he registers to participate. Thus, a walker designating Rochester chapter for the local share assures that 40% of the money s/he raises is distributed to the Rochester chapter. The remaining 20% of funds raised is split evenly between national HLAA and the local sponsoring chapter or organization to fund the costs of holding the event. National HLAA incurs costs for the W4H website, donor accounting, charge card fees and other banking costs, tee shirts and other event supplies, and travel. Local chapters and sponsoring organizations incur costs for facility rentals, food, entertainment, and supplies along with supplying the vital volunteer time and energy that is so important to the success of the day.

The board of directors met Saturday February 24 for its first regularly scheduled meeting of 2024. The Board has quarterly meetings set for the balance of the year.

The treasurer's report was received from Tom Corteville, treasurer. The Association had a positive 2023 year financially and increased its financial balance during the year.

Peter Fackler announced the formation of a finance committee as called for in the bylaws. Tom Corteville, Steve Wolfert, Sue Miller, Peter Fackler, and Tracey Rink, CPA (of Rochester) and me are on the committee.

A very encouraging report was received from HLAA Albany where efforts to strengthen the chapter's programming are bearing fruit.

The Board voted to elect Kassey Granger (Glens Falls), Dan Brooks (Rochester), and Deborah Wolfe (Westchester) as members of the nominating committee of HLAA New York State. Terms of office run to December 31, 2024.



The Board voted to accept amended bylaws for the Association. A special committee made up of Sue Miller (Rochester), Trudie Walker (North Shore), and Peter Fackler (Rochester) had worked since summer 2023 to refine and update the bylaws which form the foundational governing document that supports the work of the Association.

The Board discussed changes to national HLAA's approach to membership in the national organization. HLAA NYS bylaws provide that all New York State residents who are either members of national HLAA or of HLAA chapters are considered members of HLAA NYS. The changes to national's approach to membership will not affect the work of the Association or of the HLAA chapters.

The Interagency Council of New York State that deals with issues affecting people with disabilities has been resuscitated by Governor Hochel's administration after a long period of unfunded dormancy. HLAA NYS under the direction of advocacy committee chair, Jerry Bergman (New York City), is working vigorously to assure that we are well represented in the Council's deliberations via members we have nominated to serve. The Board and its professional advisory committee will meet with the IAC head in early March to share thoughts on priorities going forward for addressing issues that are important for hard of hearing people.

## **HLAA Book Club**

Life After Deaf is the first book selection for our chapter's new Book Club. Jennifer Lowden, Assistant Director at the Chili Library will lead a discussion of the book on Thursday, April 25<sup>th</sup> from 7 -8 p.m. via Zoom. Following is a summary:



From a renowned media critic to a man with sudden and full hearing loss, Noel Holston ran the gauntlet of diagnoses, health insurance, and cochlear implant surgery.



On a spring night in 2010, Noel Holston, a journalist, songwriter, and storyteller, went DEAF to bed with reasonably intact hearing. By dawn, it was gone, thus beginning a long process of hearing-restoration that included misdiagnoses, an obstinate health-insurance bureaucracy, failed cochlear-implant sur-

gery, and a second surgery that finally worked. He negotiated the gauntlet with a wry sense of humor and the aid of his supportive wife, Marty. Life After Deaf details his experience with warmth, understanding, and candor. It's the story not only of his way back to the world of the hearing, but of a great marriage that weathered serious testing. Their determination and resilience serve as a source of inspiration for all.

*Life After Deaf* is not just for the more than forty million people in the United States alone who cope with some form of hearing loss, but is also for their wide circles of friends, family, caregivers, and audiologists. This highly readable book will be an invaluable guide and source of hope for the large number of baby boomers now handling hearing loss.

What you don't know about hearing aids



#### A TEDx Talk by Juliëtte Sterkens

For most of us, it is not a matter of if but when we will lose some of our hearing. Yet, we do not give hearing loss or hearing aids much thought until it happens to us or someone we live or work with. It is then that we find out that hearing aids are incapable of restoring hearing to normal, especially in acoustically challenging situations. The good news is that modern technology continues to bring us new, sometimes hidden, and often unknown features that can help those with hearing loss overcome more of their hearing challenges.

Juliëtte Sterkens, AuD, is an audiologist with forty years of experience in hearing rehabilitation turned consumer advocate with the Hearing Loss Association of America. She has published numerous articles and lectured internationally to consumers, audiologists, hearing instrument specialists, and venue operators. Topics include living well with hearing loss, hearing accessibility, and hearing loops. Her work has led to hundreds of hearing loop installations in Wisconsin. She has received numerous awards for her efforts, including the American Academy of Audiology Presidential Award. She serves on the board of HEAR in the Fox Cities, a non-profit that helps pay for hearing aids for children in North-East Wisconsin.

This video, recorded at TEDxOshkosh, has been viewed over 130,000 times since it was released in March, 2024. It is an entertaining presentation describing how Telecoils work and other features of hearing aids.





The Little - The Little Theatre provides options for people with hearing loss, including hearing amplification headphones in all theaters. The hearing amplification headphones can also be used for descriptive listening.

Theatres 1, 2, 4, and 5, are equipped with Hearing Loop Systems. Personal captioning devices are available for all theaters. Please inquire at the box office.

The Little offers open caption screenings when available. Open captions mean captions are visible to everyone, and cannot be turned off. Open caption screenings are currently shown on Thursdays, along with the first matinees on Sundays (please note some films do not have an open caption version). You can find Open Caption shows via thelittle.org (listed in the showtimes on each film page), and on social media.

Roc Cinema has a hearing loop and some Saturday matinee movies are open-captioned.

**Other Theaters - Regal Theatres, Cinemark Theaters, AMC** Theaters, and Movie 10 all indicate on their websites that they have closed captioning devices available by asking at the box office. The Strand Theater in Brockport, has individual displays on goosenecks available .

### Find hearing loops on Google Maps! Here's How.

Thanks to a joint effort by HLAA's Get in the Hearing Loop (GITHL) program and Google, we can now use the Google Maps App to find out if a hearing loop is available at a business or venue. Having easy access to hearing loop locations will hearing aid and cochlear implant users find communication access when they venture out in the world. GITHL committee members are helping Google Maps add loop locations to its database.

They need your help to update information. For now, the easiest way to find hearing loops is by using a smartphone. Open a Google Maps listing and under the photos, scroll to the right to find the "ABOUT" tab. Then click on "About" and scroll down to reveal the Accessibility Attribute; if the facility offers an assistive hearing loop, it will be listed under details.
