# FROM OUR PRESIDENT, AND, VICE-PRESIDENT

These winter months in Rochester, NY area typically bring cloudy skies and short days as well as ice and snow. Traveling outside our homes can seem daunting. The average

person may experience 'cabin fever,' and opportunities for connecting with others become fewer after the holidays have passed. Feelings of isolation may invade. This is typical for all who live in the Northern Hemisphere, hearing loss or not. But what we don't often think about is the fact that people with hearing loss often experience these feelings *all year round*, as maintaining connections with others demands greater work, planning and deliberate effort. The good news is that, because of our organization, those with hearing loss already have many resources in place to dissipate social isolation. We can use these resources not only during the dark winter months, but also throughout the year. Here are just a few events members and others can look forward to enjoying in 2019:

First, HLAA-Rochester is an organization that provides "support, education and advocacy" to empower those of us who choose to take part. Our <u>monthly daytime and evening meetings</u> on the first Tuesday of each month (except July and August) provide an opportunity to socialize and meet with others. Our invited speakers provide important information regarding hearing loss research, understanding and management.



Also that day, '<u>Hearing Other</u> <u>People's Experiences'</u> (<u>HOPE</u>) sessions prior to the daytime meetings provide an

opportunity to engage in a small group setting to ask questions and learn from each other. (for more info, see page 1.) Both meetings offer an audio-looped room as well as real-time captioning (when in the Parish Hall) for ease of participation and communication.

Our Chapter holds community events for members that encourage engagement and participation. On February 10, we will spend time together at the Jewish Community Center, being entertained with a <u>captioned performance of "The British Are</u> <u>Coming!</u>" – a musical review with memorable songs and acts celebrating entertainers from that part of the world. # ORAL HEALTH AND HEARING LOSS

(excerpt from Healthy Hearing 3/18; Fox Valley, Wisconsin NL)

Healthy teeth make for an attractive smile, but did you know a healthy mouth may also protect your hearing? While it might be difficult to understand how good oral health can prevent hearing loss, think of it this way: harmful bacteria that develops in your mouth as a result of bad oral health can enter your bloodstream and cause inflammation and narrowing of arteries and blood vessels--including those essential for hearing health in your ears and brain.

Good hearing health relies on a rich supply of blood to the cochlea. Because circulation of blood is so important, good heart health is connected to good hearing. (By Brande Plotnick)

# OPEN CAPTIONS NIGHT WEEKLY AT <u>CINEMA THEATRE</u> IN SOUTH WEDGE

The Cinema Theater (957 South Clinton Ave, at S. Goodman St.) has had new owners for about a year now--Alex Chernavsky and

Audrey Kramer. They are both very interested in connecting with the local community and all the different interests within our community. For instance, Audrey is an animal rights activist who has a vegan concession stand within the theater, and hosts adoption days there.

But for our members, the most interesting news will be that <u>every Wednesday night is now " open</u> <u>captions" night.</u> The owners are aware of the large hearing loss community here, and want to be as accommodating as possible. They are looking to add a loop to the theater, but for now they have begun where they are able to: <u>with open caption</u> Wednesdays (captions displayed on the screen).

The Cinema Theater is one of the oldest neighborhood theaters in the country, and potentially the oldest in Rochester still existing. Many people do not know that they have a "family room" on the second floor that is glassed-in. You can bring your fussy child or snoring grandfather and enjoy the movie all together. They also have a house/cinema cat! Add to that the low admission price of \$7/adult or \$5/seniors & students, with double features every night, and this is a winning combination for our HLAA community.

**Parking**—free in lot across the street. Seating for 4 wheelchairs. Bathrooms—are handicap accessible.

(Full disclosure: I serve on a volunteer Advisory Board for the Cinema Theatre and am a member of HLAA-Rochester.) **"MY STORY"** –A Personal History of Hearing Loss By Gary F. Wagner



I was born in 1935 during the Great Depression in Buffalo, New York making me a "depression baby."

My father was a very successful salesman. We moved around a lot following where jobs were available. The family lived in various towns in western Pennsylvania and New York. Although I attended multiple schools, hearing was never identified as a problem with me.

Then, in 1958, with the growing conflict in Korea, I joined the NY National Guard and was assigned to 106<sup>th</sup> Armored Field Artillery in the Service Battery. Our job was to keep the 155MM cannons supplied with ammunition. Although we were right next to the guns (cannons and rifles) when they were fired, no hearing protection was offered.

My hearing loss started when I was in the middle of a lineup of at least 25 rifles at shooting practice. Afterward all I heard was a rush in my head for 3 days. Eventually the rush went away but my hearing never fully recovered as was documented during my exit physical.

After my discharge, I worked for Sears-Roebuck and had a difficult time making a living with my hearing impairment.

I then went to New York Telephone as a cable splicer's helper working out in the field. Learning to live with my hearing loss, I rose in the ranks to become a communication consultant, eventually moving to Rochester Telephone where hearing loss impacted my ability to perform my job.

There was a hearing aid office in our building. There I got my first pair of hearing aids which helped only marginally. Later, Rochester Hearing and Speech Center was one of my customers so I got tested again and I bought a pair of digital hearing aids. What a new world for me! As technology improved, I purchased increasingly powerful digital hearing aids. It was Rochester Hearing and Speech who suggested I seek out SHHH (now HLAA). I attended my first meeting in 2009. I made many new friends and still quietly assist in the chapter's growth when I can.

As a veteran, I applied for benefits to the Veterans Administration 5 years ago to cover the cost of the hearing aids and was denied!

When the scandal besieged the VA (holding off giving benefits/care to veterans to save money), I was encouraged to reapply for benefits. The second submission was successful. I was granted the benefits I had been seeking and was fitted with new hearing aids within the month of approval.

Mary and I are now both fully retired and enjoy our home and our critters (a 32-year-old Senegal parrot, a 20-year-old cockatiel, and an 18-year-old kitty (who allows us to occupy *her space*). We live in a condominium on top of a hill that, from our westward facing front room, we are afforded a spectacular show for sunsets, storms, and rainbows (and on the 4<sup>th</sup> of July, multiple towns' fireworks).

While hearing loss has created challenges (many humorous), it has also opened doors to new friends and experiences that I may not have experienced otherwise. After all, life is a journey and the ride continues to be a great one!

# TAKE YOUR NECK LOOP TO CHURCH

The 144th Annual Rochester Interfaith Thanksgiving Service was celebrated at First Baptist Church of Rochester. I decided to attend at the last minute. The church website advised that it had a hearing system. Arriving early, I found an usher, asked about their hearing system, and was referred to a lady who showed me a basket of FM receivers.

They seemed a little old, with ear buds and headphones--useless for this bilateral CI user. For once I remembered not only to bring my own neck loop but to test the batteries before leaving home! Experience has shown that although venues may advertise having hearing systems, there can be slipups especially at major events like the Thanksgiving Service, memorial services, weddings, or ordinary services of worship regardless of the denomination.

These could include:

- --Ushers not knowing if the church has a system.
- --Ushers not knowing how/where it can be found immediately.
- --If FM receivers, batteries might be dead.
- --As above, connections do not suit the hearing impaired user.
- -- Rochester curiosity of calling every hearing system a "loop" even if it is an FM system.

Advice to those attending an event in a "new" house of worship:

- --Check the website for mention of accessibility.
- --Email or phone to double check.
- --Stop by and talk to office personnel to warn them that someone will ask for it.
- --Arrive EARLY and approach someone who looks authoritative to request an FM receiver OR find a seat close enough to see speakers' faces and nearer the walls (loops tend to circle the sanctuary).
- --Hope to make sense of the proceedings.
- --Return FM receivers.
- --Thank all those who helped you !

Rochester deaf comedian **Tom Willard** made his Broadway debut December 3<sup>rd</sup> at New York City's Carolines on Broadway.

Willard spoke and signed his jokes at Carolines' New Talent Showcase, "where the country's top upand-coming comedians shine." Willard started doing standup in 2016. He has performed in nearly a dozen cities --Toronto, Cleveland and Hartford.

He's an RIT alumnus, having earned a photo degree in 1985 through NTID.

He signs while he tells his jokes, making his act accessible to hearing and deaf people alike. "I performed at a school for the deaf and everyone laughed at the same time," he said. "That rarely happens when there's an interpreter involved."

In addition to performing, he advocates to make comedy accessible to people with hearing loss. Last August, he was successful at getting both the Pittsburgh Comedy Festival and the Lucille Ball Comedy Festival to provide real-time captioning at several shows.

The Device Demo Center session on January 17<sup>th</sup> was a great success, thanks to the enthusiastic efforts of all of those involved.

The types of devices represented include signalingalerting devices, captioned telephones and personal assistive listening devices [with an emphasis on TV listening and coping with noisy environments].
